## Representative Matters

- Acted for Grab in its US\$40 billion merger with SPAC Altimeter Growth and Nasdaq listing, which included preparing a legal opinion for the purposes of the listing, conducting due diligence on Grab's businesses in Indonesia and reviewing Grab's Form F-4.
- Acted as Indonesian counsel for General Electric in connection with its global spin-off into three public companies in the aviation, healthcare, and energy sectors.
- Led the SSEK team that advised the Indonesian Ministry of State-Owned Enterprises and then acted for PT Pertamina (Persero), the Indonesian state-owned oil and natural gas corporation, in the formation of the Indonesian Oil and Gas Holding SOE, a US\$4 billion deal that resulted in the creation of Indonesia's largest state-owned holding company.
